

City of Lapeer Parks and Recreation Department YOUTH FINANCIAL ASSISTANCE GUIDELINES

Recognizing that certain youth do not have the financial resources to participate in recreation activities offered by the City of Lapeer Parks and Recreation Department and the City of Lapeer Community Center a fee assistance program has been established.

Eligibility: Funds provided by United Way of Lapeer County are available to any Lapeer County resident on a first-come-first-serve basis, subject to the Youth Financial Assistance Guidelines. Should United Way funds not be available, youth financial assistance will only be available to residents of cities and townships who participate in providing funds for this purpose. A list of participating cities and townships is available at the City of Lapeer Parks and Recreation Department.

Guidelines: Financial assistance is open to youth age 17 and under who meet the income standards listed in the chart below. (Should applicant not meet the income requirements but can prove extenuating circumstances, temporary to their situation, assistance may be granted.) Please allow five (5) days for processing. Assistance is limited.

All City of Lapeer Community Center and City of Lapeer Parks & Recreation programs and activities are eligible. Each child is eligible to receive financial assistance toward one (1) program or activity per quarter. Daily admission to the Community Center is limited to ten (8) visits per quarter. Registration policies and procedures are outlined in the quarterly brochure. Assistance will be made on a funds available basis.

Application Procedure: All requests must be submitted on a City of Lapeer Youth Financial Assistance Application and signed by a parent/guardian. Total annual family income includes income from all of the following sources:

- All wages and salaries of working family members
- Self-employment income
- Social security
- Public assistance or welfare payments
- Alimony or child support payments
- Any other cash income

Also, one of the following pieces of documentation must accompany each application form:

- Approved Free and Reduced Price Meal Program Form
- W-2 Form
- DSS Form
- SSI Form
- Social Security Statements
- Unemployment Statement

Important Information:

- Assistance is limited to one activity or program per child, per quarter. Daily admission to the Community Center is limited to eight (8) visits per quarter.
- Application for and/or approval of financial assistance does not guarantee a space is available in the chosen activity. A separate registration form is necessary. Please allow five (5) days for processing.
- Granting of assistance is based on total family income level (see chart at right). Should applicant not meet the income requirements but can prove extenuating circumstances, temporary to their situation, assistance may be granted.
- Participant may be required to pay a portion of the program cost.
- Application must be submitted with proper documentation.
- It is intended that this assistance be temporary.
- Decisions regarding assistance are final.

Income requirements are based upon Lapeer Community Schools Free and Reduced Lunch Program.
